MILITARY EDUCATOR (S) OF THE YEAR AWARD

A recipient could be someone who is not a VA-ACME member but is nominated by a VA-ACME member. The recipient has the respect and admiration of their colleagues. The recipient guides the military community to achieve excellence, creates a culture of respect, and success. The recipient demonstrates leadership and innovation while embodying practices for lifelong learning. Open to Military Affiliated, Civilian or both.

Eligibility: A person directly serving military members in military educational arenas. (i.e. Military Installations, Colleges & Universities, or Government Personnel)

Criteria for Nomination: An individual who made a significant contribution to military education.

Nomination Process: A VA-ACME member must submit the nomination.

SPONSORSHIP AWARD(S)

Eligibility: A recipient could be a corporate/institution (or both) sponsor (s) of VA-ACME. Recipient (s) would receive a medallion/plaque and a certificate, to be determined by the VA-ACME Awards Committee. This award (s) recipients' will reflect attributes related to creativity, leadership, integrity, professional excellence, and service to the global military community (global awareness) displayed by the corporation or institution as it relates to military education.

Criteria for Nomination: Award is presented in recognition for outstanding contributions and accomplishments to an organization in recognition of its significant contributions to the cause of military education.

Nomination Process: VA ACME Executive Board selects recipient of the award in conjunction with the VA-ACME Awards Chair. Nominations are also accepted from VA-ACME members. Organizational representatives may nominate their organization. Nominations should include name of individual making the nomination, contact information (phone #; email address); point of contact information for the nominee and no more than one 8 ½ X 11 page detailing why this individual deserves recognition by the VA-ACME Board.

VOLUNTEER OF THE YEAR AWARD

Eligibility: A recipient could be an individual (s) who has contributed to VA-ACME through volunteer efforts. This individual (s) will have made important contributions towards military education that have influenced, impacted, and provided a supportive role in the assistance in the influence of military education locally or internationally while demonstrating exemplary commitment, earning respect from others, displays admiration and epitomizes dedication for the military community.

Criteria for Nomination: Award is presented to a VA-ACME member for recognition of outstanding contributions and accomplishments to the cause of military education and the VA-ACME.

Nomination Process: Each VA-ACME committee chair will submit a name of a deserving member for Volunteer of the Year Award. VA-ACME's Executive Board will select recipient of the award in conjunction with the VA-ACME Awards Chair. In addition, VA-ACME members can select a recipient for this award. Individuals may *not* nominate themselves.

PRESIDENT'S AWARD

Eligibility: This is a service award for lifetime contributions to military education. The distinctive award exemplifies and recognizes an individual's outstanding and sustained contributions. This individual demonstrates their devotion in their professional life by continuously making an impact on military education. The award will be deserving of someone who has had an influence in the development and improvements towards military education.

Criteria for Nomination: An individual or organization making a significant contribution that advances the cause of military education.

Nomination Process: VA-ACME Executive Board selects recipient of the award in conjunction with the VA-ACME Awards Chair. Nominations can be accepted from VA-ACME members. Individuals *may* nominate themselves.
